This is an accessibility statement from aanmelder.nl.

Measures to support accessibility

aanmelder.nl takes the following measures to ensure accessibility of aanmelder.nl:

- Include accessibility throughout our internal policies.

Conformance status

The [Web Content Accessibility Guidelines \(WCAG\)](#) defines requirements for designers and developers to improve accessibility for people with disabilities. It defines three levels of conformance: Level A, Level AA, and Level AAA. aanmelder.nl is partially conformant with WCAG 2.2 level AA. Partially conformant means that some parts of the content do not fully conform to the accessibility standard.

Limitations and alternatives

Despite our best efforts to ensure accessibility of aanmelder.nl , there may be some limitations. Below is a description of known limitations, and potential solutions. Please contact us if you observe an issue not listed below.

Known limitations for aanmelder.nl:

1. **Charts:** Charts are not perceivable for blind users because our chart library does not support this. Update our chart library or find another that does.
2. **Zoom:** At 400% zoom content is not well perceivable because parts were not build with this adjustment in mind (mainly navigation). We are creating a new navigation with this in mind.
3. **Text spacing:** Some content is not well accessible after adjusting text spacing because parts were not build with this adjustment in mind. Issue is added to our roadmap.
4. **Page layout:** Page regions should be available and marked properly. With the creation of the new navigation this will also be solved.
5. **Headings:** Headings are not always marked properly because we used headings more as a styling approach than for semantics. Most of these have been fixed the rest are added to the roadmap.

6. **High Contrast:** Some important content is not well perceivable. Issue has been added to the roadmap
7. **Pop-ups:** Keyboard focus is not set into some pop-ups. Working on a focus trap for pop-ups which works together with all current widgets.
